I am requesting \$230,400 in funding for the Public Service District #3 Meter Project in Marshall County, West Virginia.

The funding is designated for adding a meter to 22 of Marshall county's main water lines. This addition will make leak detection even more efficient and help cut leakage cost by \$5-6,000.00 per month. In essence saving the District a minimum of \$60,000.00 per year.

The project is an appropriate use of taxpayer dollars because the district averages a loss of 1 million gallons/month. In March 2021, their loss was almost 2 million gallons.
